FIRST AID MEASURES

EYES: Wash immediately with plenty of water for at least 15 minutes and seek medical advice at once.

FIRE-FIGHTING MEASURES

GENERAL INFORMATION

PERSONAL PRECAUTIONS

ENVIRONMENTAL PRECAUTIONS

The product must not penetrate the sewers, surface water, ground water and neighbouring areas. Dilute the product well with water after collection.

METHODS FOR CLEANING UP

Suck the liquid into a suitable container and soak up any leaked product with absorbent inert material (sand, vermiculite, Tripoli powder, universal cement, etc.). Neutralize remaining material. Make sure the leakage site is well aired. Contaminated material should be disposed of in compliance with the provisions set forth 'DISPOSAL CONSIDERATION'.

HANDLING AND STORAGE

Make sure that equipment is available for cooling the vessels, to prevent the danger of overpressure and overheating in the event of fire in the vicinity. Refer to the other sections of this data sheet for information relating to health and environmental risks.

EXPOSURE CONTROL / PERSONAL PROTECTION

Exposure controls

As the use of adequate technical equipment must always take priority over personal protection equipment, make sure that the workplace is well aired through elective local aspiration or bad air vent. If such operations do not make it possible to keep the concentration of the product below the permitted workplace exposure thresholds a suitable respiratory tract protection must be used. Ask your chemical substance suppliers for advice when choosing personal protection equipment. Personal protection equipment must comply with the rules in force indicated below.

HAND PROTECTION:

Protect hands with work gloves, such as those in latex, PVC or equivalent. The following should be considered when choosing work glove material: degradation, breakage times and permeation. Work glove resistance to preparations should be checked before use, as it can be unpredictable. Gloves' limit depends on the duration of exposure.

EYE PROTECTION:

Wear hood visor or protective visor together with airtight goggles.

SKIN PROTECTION:

Wear professional long-sleeve overalls and safety footwear. Wash body with soap and water after removing overalls.

RESPIRATORY PROTECTION:

If the threshold value for one or more of the substances presents in the preparation for daily exposure in the workplace or to a fraction established by the company's prevention and protection service is exceeded, wear a mask with an B or universal filter. The use of breathing protection equipment, such as masks with organic vapor and dust/mist cartridges, is necessary in the absence of technical measures limiting worker exposure. The protection provided by masks is in any case limited.
